6. Any types of fee will not be refundable in any circumstances.

7. No liabilities regarding the staff salaries, taxes, computers, computer's software & your official

problems will be borne by H.O. office DIIT, Delhi and sending material expenses like a kits sending

expenses

EXPECTATION FROM THE AFFILIATED STUDY CENTRE

➤ The study centre should be able to have a centre at a prime location of the city/town.

➤ The centre would have separate class rooms, Computer Lab and Reception / office room.

➤ The centre would have proper ventilation and proper lighting. The block and sub block level centres

may not have the above infrastructure but should have generally clean surroundings.

➤ The DIIT study centre shall abide by the agreement and conditions followed by all DIIT centres.

➤ The DIIT study centre shall have to conduct courses as per the rules and syllabi laid down by DIIT.

➤ The DIIT study centre shall deposit an advance nonrefundable affiliation fee.

➤ This amount shall be deposited at the time of signing the affiliation agreement.
